2. The total cost of tuition is \$9,250 for 84 hours of training.
3. A \$1,000.00 deposit will be submitted with this application.
4. The balance of my tuition shall be paid on or before the first day of class.
5. Tuition includes a \$150.00 non-refundable application fee.
6. Student books, silencer, CAT System, and peripherals are included in the cost of tuition and will be provided during the course.
7. Upon successful completion of the course, I will receive a certificate of completion.
8. I will adhere to the rules and regulations set forth in the South Carolina School of Court Reporting Student Information Publication.
9. I may cancel this agreement, without penalty, by notifying the South Carolina School of Court Reporting within three business days after signing this agreement.
10. Should I desire to cancel this agreement after the expiration of the no-penalty grace period, but before classes begin, I may incur a \$100.00 cancellation fee.
11. Should I desire to cancel this agreement after the expiration of the no-penalty grace period, but after classes begin and before completion of the first 60 percent of the course, I may incur a \$100.00 cancellation fee plus a pro-rata tuition charge based on the last date attended, rounded down to the nearest 10 percent of that period.
12. Should I desire to cancel this agreement after completion of more than 60 percent of the course, the South Carolina School of Court Reporting may retain the entire cost of the course.
13. Should I desire to cancel this agreement, the South Carolina School of Court Reporting will make refunds within 40 days after the effective date of cancellation or the last date of course attendance.
